

The color pink was chosen to avoid being like the black POW/MIA stone, but its design was planned to fit in with other stones not yet placed It was to have a somewhat slanted front. However, due to complications (the two co-chairmen, Janice Mugford & Mary Moran, and Mike Kinney, founder of the park), the stone that arrived on the day before the dedication was not what was ordered, and, in the minds of the committee resembled a cemetery stone. However, they no choice but to accept it.


This monument was dedicated on 10 A.M. Saturday, June 29th, 1991, honoring Desert Storm veterans of Chelmsford. This dedication took place a year before the park itself was dedicated. Desert Storm veterans present at the unveiling of the stone included Airman First Class Sgt. Charles Swanson and Army Spec. 4 Michael Russo, who had just returned the previous Monday. He said after the ceremony, "It pleases me a lot to see that everyone is up and at 'em about our serving in the Gulf. This is the spirit I was hoping for when I was sent over there." Also present was "Army Spec. 4 Brad Cassie, who was a resident of New Jersey but was staying with Russo."

"Town manager Bernard Lynch awarded the three Chelmsford Desert Storm veterans with medalions in recognition of their efforts on behalf of their country, while Police Chief Raymond McKeon expressed his pride in both his town and its residents. 'As a Korean War veteran, I find it particularly satisfying to experience the strength and patriotism that is permeating our country,' he said. 'I'm sure the Desert Storm veterans will not be forgotten.'"

The granite monument was "unveiled by Emblem Club president Kathie Bradley and junior past president Karen Dunn

The Emblem Club, which is affiliated with the Elks, raised all the funds for the perpetual monument and its engraving."


