FIRST GENERATION

George Parkhurst, son of John Parkhurst and Sarah unknown. Born, circa 1588, in Ipswich, Co. Suffolk, England. Buried, 18
Jun 1675, in Ipswich, Co. Suffolk, England. Occupation: Farmer. Reference: 1.

George was born during 1588 possibly in May, probably in Ipswich, England. George and his wife, Phebe Leete, lived in Ipswich where their nine children were baptized, but after the last child was baptized there is no record of them in Ipswich and they may have lived elsewhere until their departure for New England.

George's arrival date in New England can be estimated by the marriages contracted by his children in Massachusetts prior to 1640. George first appears on record in New England at Watertown, MA in 1642 when it was ordered that a highway should be laid out to his house. He is not mentioned in the four grants of land made in Watertown between 25 July 1636 and 9 April 1638. Whether he brought with him his wife, Phebe, is unknown. If he brought her she died shortly afterwards, for about 1644, he married his second wife, Susanna Simson, the widow of John Simson, (who was buried at Watertown on 10 June 1643, leaving two sons and three daughters).

The time period when George and Susanna were married can be determined by sales of Simson's real estate. Susanna held title after John's death and deeded some of the land on 9 November 1643. George sold two acres of Simson's land on 16 November 1644, having acquired title by his marriage to Susanna. They were living in Boston by 1645 as evidenced by a deed George made there on 4 October 1645 selling six more acres in Watertown.

On 13 June 1655, George sold the last 12 acres of what had been John Simson's land for 21 pounds. This conveyance was made by permission of the General Court, granted 23 May 1655 in response to his petition in which he asserts that he was then "near 67 years old", that he and his wife, who was in England, and most of her children were in destitute condition, that she had 10 children during her 20 years of residence in America - seven sons and three daughters (five sons by Parkhurst therefore), that she had gone to London, England with six of her children but found her mother, brothers and sisters were unable to do what she had expected, that four of her children had remained in America, and that the petitioner desired to sell the land (apparently all that remained) in order that he might go to the aid of his wife. George probably returned to England as soon as possible after the deed of 13 June 1655, his last act on record in New England.

George was probably the "Old George Parkhurst" buried 18 June 1675 at Saint Lawrence, Ipswich, England. He may have been living with his cousin Nathanial Parkhurst, who had six hearths in the Suffolk Hearth Tax of 1674.

He married, first, Phebe Leete, daughter of Robert Leete and Alice Grundy, circa 1611, in England. Christened, 20 Dec 1585, in Little Eversden, Cambridgeshire, England. Died, before 1641, in England. Reference: 1W.

Phebe (Phebe "unknown" in some early Parkhurst genealogies) was the youngest of seven children. She had a sister, Ruth, wife of Reverend Timothy Dalton, Rector of Woolverstone, which is five miles from Ipswich, England. Timothy Dalton and Ruth Leete were married on 13 June 1615 at Gislingham, Suffolk. Ruth died in New Hampshire without surviving children and left legacies to six Parkhurst children of her sister, Phebe, suggesting that Phebe's children Samuel, John, and Abigail had died young.

i. Phebe² Parkhurst. Christened, 29 Nov 1612, in Ipswich, Co. Suffolk, England⁵. Died, circa 1700, in Providence, Providence Co., RI. She married, first, Daniel Dan, 27 Mar 1635, in Wolverstone, Co. Suffolk, England⁷. She married, second, Thomas Arnold, son of William Arnold and Katherine unknown, circa 1640, in Watertown, Middlesex Co., MA⁶. Reference: 11.

Phebe's first marriage took place at Wolverstone, the home of her Aunt Ruth (Leete) Dalton.

ii. Mary Parkhurst. Christened, 28 Aug 1614, in Ipswich, Co. Suffolk, England⁹. Died, 28 Mar 1687, in Woburn, Middlesex Co., MA¹⁰. She married Thomas Carter, son of James Carter and Mary unknown, before 1640, in Watertown, Middlesex Co., MA¹¹. Reference: 12.

Mary's husband, Thomas Carter, was living in Watertown, MA before 1637. Mary's first child was born early in August 1640 in Watertown. This places Mary in Watertown by 1639. She probably arrived with her father and some of her siblings and this helps to date the arrival time of George and his family to 1638 or 1639.

iii. Samuel Parkhurst. Christened, 2 Feb 1616/7, in Ipswich, Co. Suffolk, England¹². Died, before 1641, in England¹³. Reference: 13.

Samuel probably died young in England since he was not mentioned in his Aunt Ruth (Leete) Dalton's will.

iv. Deborah Parkhurst. Christened, 1 Aug 1619, in Ipswich, Co. Suffolk, England¹². Died, circa 1686, in Edgartown, Dukes Co., MA¹⁴. She married John Smith, circa 1638, in Watertown, Middlesex Co., MA¹⁵. Reference: 14.

Deborah probably married shortly after she arrived with her family at Watertown, MA.

v. George Parkhurst. Christened, 5 Jun 1621, in Ipswich, Co. Suffolk, England¹². Died, 16 Mar 1698/9, in Watertown, Middlesex Co., MA¹⁶. He married, first, Sarah Browne, daughter of Abraham Browne and Lydia unknown, 16 Dec 1643, in Watertown, Middlesex Co., MA¹⁷. He married¹⁸, second, Mary unknown, 24 Sep 1650, in Watertown, Middlesex Co., MA¹⁹. Reference: 15.

George, Jr. was the oldest surviving son of George Parkhurst and Phebe Leete. He came as a boy to Watertown with his father and siblings and remained in Watertown the rest of his life, even when his father returned to England. He settled on the old Parkhurst farm in a part of Watertown that later became part of Waltham. His farm was located on the east side of Beaver Brook and on the north side of the old county road. The house stood a few rods east of the cottage of Thomas Page.

vi. John Parkhurst. Christened, 19 Oct 1623, in Ipswich, Co. Suffolk, England¹². Died, before 1641, in England¹³.

Reference: 16.

John probably died young in England since he was not mentioned in his Aunt Ruth (Leete) Dalton's will.

vii. Abigail Parkhurst. Christened, 1 Jan 1625/6, in Ipswich, Co. Suffolk, England¹². Died, before 1641, in England¹³. Reference: 17.

Abigail probably died young in England since she was not mentioned in her Aunt Ruth (Leete) Dalton's will.

viii. Elizabeth Parkhurst. Christened, 18 May 1628, in Ipswich, Co. Suffolk, England²⁰. She married, first, Emanual Hill(i)ard, circa 1650, in Hampton, Rockingham Co., NH. She married, second, Joseph Merry, 14 Dec 1659, in Hampton, Rockingham Co., NH⁷. Reference: 18.

Elizabeth was probably living with her Aunt Ruth (Leete) Dalton in Hampton, NH prior to her first

marriage in 1650. She moved to Martha's Vineyard in 1670 with her second husband. It is not known when she died and no stone marks her grave.

2 ix. Joseph Parkhurst.

He married, second, Susanna unknown (widow Simson), circa 1644, in Watertown, Middlesex Co., MA². Born, circa 1610, in England. Died, circa 1690, in greater London, England, probably. Reference: 1X.

Susanna, widow of John Simson, who married George Parkhurst as his second wife, may have been nee Brown, as she interacts with Browns in Watertown, MA. Susanna returned to England before 1655. Except for Benjamin Parkhurst, the children Susanna took back to England probably grew up there, and never returned to New England.

Children:

x. son Parkhurst. Born, circa 1645, in Boston, MA or Watertown, MA⁷. Died in greater London, England, probably⁷. Reference: 1A.

George Parkhurst's petition for permission to sell land in 1655 stated that Susanna had ten children while in New England. Of these ten children, five sons were fathered by George. Records have been found for four of these sons. This son, name unknown, could have been either the first or second born. He was probably taken back to England by his mother and died somewhere in the greater London area never returning to America.

xi. Benjamin Parkhurst. Born, circa 1647, in Boston, Suffolk Co., MA⁷. Died, circa 1683, in Elizabethtown, Essex Co., NJ²¹. Inventory: 16 Feb 1683/4, in Elizabethtown, Essex Co., NJ⁷. Occupation: Joiner. He married Martha Homan, daughter of William Homan and Winnifred unknown, circa 1675, in Elizabethtown, Essex Co., NJ⁷. Reference: 1B.

Benjamin was either the first or second son of George and Susanna. He was born either in Watertown, MA or more probably in Boston between 1645 and 1648. If he was taken back to England by his mother, he apparently returned as a young man to his American brothers and sisters and then migrated to New Jersey.

Benjamin's half-brother, George, Jr., wrote to his cousin Bashelder on 25 June 1669 requesting payment to Benjamin of five pounds of the 20 pounds which would be due George, Jr. from his legacy from his Aunt Ruth Dalton. This letter shows that Benjamin was probably in New England and was in contact with at least some of his Parkhurst half-siblings, and lends further support to the identity of the Benjamin Parkhurst in New Jersey the next year.

Benjamin is on record as being in Woodbridge about 1670. He was one of the first settlers of Woodbridge. He exchanged his properties at Woodbridge on 8 Aug 1672, with Claude Vallot of Elizabethtown, and became a permanent resident of Elizabethtown. He was appointed Lieutenant of the Company of Foot on 22 March 1679/80, and was listed as Justice of the Peace on 4 February 1682/3, Judge of Small Causes on 28 March 1683, and Captain of the Company on 3 December 1683.

When he died, probably in February 1683/4, the inventory of his estate established a value of 188 pounds 16 shillings.

xii. Daniel Parkhurst. Christened, 10 Jun 1649, in Boston, Suffolk Co., MA²². Died in greater London, England, probably⁷. Reference: 1C.

Daniel was probably taken back to England by his mother and died somewhere in the greater London area never returning to America.

xiii. Joshua Parkhurst. Christened, 7 Mar 1652/3, in Boston, Suffolk Co., MA²³. Died in greater London, England, probably². Reference: 1D.

Joshua was probably taken back to England by his mother and died somewhere in the greater London area never returning to America.

xiv. Caleb Parkhurst. Christened, 26 Feb 1653/4, in Boston, Suffolk Co., MA²⁴. He married Sarah unknown in Cripplegate, Co. London, England⁷. Reference: 1E.

Caleb was probably taken back to England by his mother. He was probably the Caleb Parkhurst with wife, Sarah, of St. Giles, Cripplegate, London whose five children were baptized there.

SECOND GENERATION

Joseph² Parkhurst (George¹). Christened, 21 Dec 1629, in Ipswich, Co. Suffolk, England¹². Died, 30 Nov 1709, in Chelmsford, Middlesex Co., MA²⁵. Reference: 19.

Joseph probably came to Watertown, MA before 1640 with his father and siblings. Joseph was a proprietor (original settler) of the New Field (a new district or "town") in Chelmsford, MA and was allotted 12 acres on 12 March 1666/7. His house lot was located "west by town highway to the mill, north by land of Thomas Sewell, east by town common, south by land of John Wright". This location is now on Stedman Street, Lowell, MA.

On the ministerial tax list of 1672, Joseph was listed with eight acres (tillable?), three cows, two oxen (1 - 2 years old), two yearlings, five swine, and one horse. Sometime later Joseph moved to the Stoney Brook district, which is now in Westford, where he died.

He married Rebecca Reade, daughter of Esdras Reade and Elizabeth Watson, 26 Jun 1656, in Concord, Middlesex Co., MA²⁶.

Marriage(2): 24 Jun 1656, in Chelmsford, Middlesex Co., MA²⁷. Christened, 27 Sep 1627, in Southwark, Co. Surrey, England²⁸. Died, before 1703, in Chelmsford, Middlesex Co., MA²⁹. Reference: 19W.

Rebecca was said to be "of Chelmsford", as was her husband, when they were married in Concord. Her family was located in various towns in Massachusetts before 1656. The Salem Quarterly Court record of 17 September 1650 says: "Joshua Ray was admonished for abusing the body of Rebecca Reade in an uncomely manner with a stick".

Rebecca died before her husband, as shown by a deed dated 25 December 1702, when Joseph, Sr., and their son, Joseph, Jr., sold to John Snow "a certain parcell of land & medowe in Chelmsford at a place called Little Tadnock and also 3 acres of medowe at great Tadnuck". Only one wife signed the deed, Eunice Parkhurst, the wife of Joseph, Jr.

Children:

Mary Parkhurst. Born, 10 Aug 1657, in Chelmsford, Middlesex Co., MA³⁰. Died, 6 Sep 1694, in Chelmsford, Middlesex Co., MA³¹. She married Thomas Blodgett, son of Daniel Blodgett and Mary Butterfield, 29 Jun 1683, in Chelmsford, Middlesex Co., MA³². Reference: 191.

The Chelmsford Vital Records list Mary's death as 6 September 1694 and list her son Benoni's birth as occurring on 22 October 1694. It is possible that Mary died on 6 September 1695, not 1694. Benoni's birth then could have been 22 October 1694 (as the records show) or it is possible he was born in 1693.

ii. Rebecca Parkhurst. Born, 14 Aug 1659, in Chelmsford, Middlesex Co., MA³⁰. Died, 30 Oct 1722, in Chelmsford, Middlesex Co., MA³³. Burial in Forefather's Cem, Chelmsford, Centre, MA³⁴. She married Edward Foster, son of Samuel Foster and Esther Kemp, circa 1689, in Chelmsford, Middlesex Co., MA. Reference: 192.

"Elias Foster", sometimes said to be a son of Rebecca and Edward Foster, was most likely the son of Edward's brother, Eli Foster.

 - iv. Abigail Parkhurst. Born, 14 Mar 1664/5, in Chelmsford, Middlesex Co., MA³⁰. Died, after 1728³⁵. She married Nathaniel Cummings, son of John Cummings and Sarah Howlett, 14 Apr 1697, in Chelmsford, Middlesex Co., MA³³. Reference: 194.

Abigail was residing with her son, John Cummings, in Dunstable, MA on 23 Feb 1729.

v. Ebenezer Parkhurst. Born, 2 Dec 1671, in Chelmsford, Middlesex Co., MA. Died, 9 Nov 1745, in Chelmsford, Middlesex Co., MA. Be married, second, Sarah French, daughter of Samuel French and Sarah Cummings, circa 1734, in Chelmsford, Middlesex Co., MA. Intention, Dec 1733, in Chelmsford, Middlesex Co., MA. Reference: 195.

Ebenezer was born and lived his entire life in Chelmsford, MA. No record of his marriage to his wife Mary has been found, but he probably was married in Chelmsford or in one of the surrounding towns.

Ebenezer's home in Chelmsford was called the "Owl's Nest" because of the numerous owls that nested in nearby trees. The present house was built by Andrew and John Parkhurst in 1804, on land from the original Parkhurst grant. This house is located at 16 Parkhurst Road, Chelmsford, MA.

3. Joseph Parkhurst (Joseph , George). Born, 12 Jan 1661/2, in Chelmsford, Middlesex Co., MA o. Died, 11 Dec 1720, in Plainfield, Windham Co., CT e. Reference: 193.

Joseph was born, grew up, and was married in Chelmsford, MA. Joseph was one of the 24 original incorporators and first settlers of Plainfield, CT. He moved to Plainfield from Chelmsford about 1701. Joseph settled in the northwestern part of the town and was a prominent member of the community. He was appointed commissioner for settling land claims of the proprietors and was chosen as a representative to the colony's government from Plainfield in 1713 and 1714.

The original tract of land owned by Joseph extended from what is now called the Brooklyn Road, north across the dividing line of Killingly and Plainfield. The farm house was built about one-quarter of a mile from the present road, near a fine spring. Afterwards, a second house was built about midway towards the road. Part of the property was still owned by his descendants as late as 1896.

On 10 December 1720, being sick, Joseph made his will and died a few hours later. Among the witnesses to this death bed will was one William "Blogett", a local Plainfield "doctor". Just a year before William had been convicted of adultery with Hannah Pierce and was sentenced "to be whipt 25 stripes and branded on the forehead with A and a halter put on his neck, there to remain forever". In 1721 "Blogget" applied to the General Court for a license to practice medicine in Connecticut, giving full proof of moral character and of the satisfaction of the people with his skill, but his petition was denied on the grounds that he was illiterate and should not licensed in a learned profession. Probably, this incompetent man bled Joseph and, in his weakened condition, he died from the treatment within hours. Left alone Joseph might have lived another twenty years. The inventory of his estate indicated a substantial and prosperous farm, the result of 18 years of industry in this new settlement.

He married Eunice Spalding, daughter of John Spalding and Hannah Heald, 4 Nov 1686, in Chelmsford, Middlesex Co., MA **. Born, 27 Jul 1661, in Chelmsford, Middlesex Co., MA **. Died, 19 Jan 1743/4, in Plainfield, Windham Co., CT **. Reference: 193W.

Children:

 Timothy⁴ Parkhurst. Born, 14 Jan 1688/9, in Chelmsford, Middlesex Co., MA⁴². Died, 3 Mar 1770, in Plainfield, Windham Co., CT⁴³. He married Elizabeth Cady, daughter of Nicholas Cady and Patience Redland, 15 Jan 1716/7, in Killingly, Windham Co., CT⁴⁴. Reference: 1931.

Timothy, while still in his boyhood, moved with his parents from Chelmsford, MA to Plainfield, CT. He was surveyor of highways in 1723 and assessor in 1724. He probably lived on the part of his father's farm that was in, or near, the town of Killingly, CT, as some sources list his children as being born in Killingly and their baptisms are found in the Killingly Church records.

Plainfield, Windham Co., CT . He married, second, Judith Haynes, 12 Aug 1741, in Plainfield, Windham Co., CT . Reference: 1934.

Joseph, while still a young child, moved from Chelmsford, MA to Plainfield, CT with his parents who were early settlers there. He met and married his wives in Plainfield.

Late in life, Joseph followed some of his children and moved to Royalton, VT.

No further record of Hannah has been found. She probably died young.

vii. Samuel Parkhurst. Born, 25 Apr 1701, in Chelmsford, Middlesex Co., MA⁵¹. Died, 22 May 1778, in Plainfield, Windham Co., CT⁵². Will dated: 3 Feb 1773, in Plainfield, Windham Co., CT⁵³. Burial: 1778, in Old Plainfield, Cem., Plainfield, CT⁵⁴. Adm Freeman: 19 Dec 1722, in Plainfield, Windham Co., CT⁵⁵. He married, first, (H)ester Spaulding, daughter of Edward Spaulding and Elizabeth Hall, 20 Jan 1730/1, in Plainfield, Windham Co., CT⁵⁵. He married, second, Mary Hutchins, daughter of John Hutchins and Mary Wyman, 24 Feb 1742/3, in Plainfield, Windham Co., CT⁵⁷. Reference: 1937.


Samuel, while a very young child, moved with his parents from Chelmsford, MA to Plainfield, CT. He was assessor of taxes in 1750 and a member of the committee "to fix rates of, and defray charges for" the meeting house in 1754.

Samuel died from a mortification in his leg according to the Plainfield Church Records.

viii. Mary Parkhurst. Born, 18 Nov 1702, in Plainfield, Windham Co., CT⁵⁰. Died, 30 Nov 1789, in Plainfield, Windham Co., CT⁵⁰. Burial in Old Plainfield, Cem., Plainfield, CT⁵⁰. She married Thomas Pierce, son of Thomas Pierce and Mary Wyman, 1723, in Plainfield, Windham Co., CT. Reference: 1938.

Mary was the first white child born in the new settlement of Plainfield, CT. Mary and her husband, Thomas Pierce, were second cousins once removed. Their common ancestors were George Parkhurst and his first wife, Phebe Leete.

Only three children, John, Lois, and Eunice, of Mary and Thomas survived long enough to be named in Thomas' will.

4. John Parkhurst (Joseph Joseph George). Born, 1 Mar 1690/1, in Chelmsford, Middlesex Co., MA O. Died, 17 Nov 1771, in Plainfield, Windham Co., CT Reference: 1932.

John, while still a child, moved from Chelmsford, MA to Plainfield, CT with his parents who were early settlers there. He met and married his wife in Plainfield and lived the rest of his life in this town. He was confirmed as Lieutenant of the 2nd company of the Plainfield Training band in May 1736 and was promoted to Captain in October 1739.

John purchased all the lands that had not before been given away, sold, or disposed of from the remaining heirs of his father, who is spoken of in the deed as "our late honard father Joseph Parkhurst".

He married Abigail How(e), daughter of Samuel How(e) and Mary Nutting, 1 Nov 1714, in Plainfield, Windham Co., CT Born, 27 Feb 1692/3, in Concord, Middlesex Co., MA Died, 10 Jan 1774, in Plainfield, Windham Co., CT Reference: B1-17.

Children:

Phinehas⁵ Parkhurst. Born, 28 Apr 1716, in Plainfield, Windham Co., CT⁶³. Died, 20 May 1778, in Boston, Suffolk Co., MA⁶⁴. Occupation: Surgeon. Reference: 19321.

Phinehas was a surgeon on the brig Resistance. She was carried on the accounts of Nathaniel Shaw, Jr., Naval Agent at New London, CT. Phinehas died of "West Indies Fever" just after returning from a voyage. It appears that he never married.

ii. Joseph Parkhurst. Born, 25 Jun 1721, in Plainfield, Windham Co., CT⁶⁵. Died, 4 Nov 1814, in Royalton, Windsor Co., VT⁶⁶. Burial: 1814, in N. Royalton Cem., Royalton, Windsor Co., VT⁶⁷. Occupation: Farmer. He married Mary unknown, circa 1742⁶⁸. Reference: 19322.

No marriage record for Joseph and his wife, Mary, has been found. Confusion exists among the many Joseph Parkhursts, especially between this Joseph and his uncle, also named Joseph, who married as his second wife, Judith Haynes Johnson, in Plainfield, CT on 12 August 1741.

Joseph was one of the earliest settlers of Sharon, VT. He was one of 13 who took the Vermont Freeman's Oath on 3 March 1778 in Sharon.

On 27 August 1785, Joseph deeded his farm of 100 acres in Sharon for 300 pounds to his son, Reuben, who on the same day leased it back for the lifetime of his parents, for an annual rent of 3 shillings.

Joseph was probably living with his son Benjamin when the 1810 Census was taken. He was buried near his son, Benjamin, in the North Royalton, VT Cemetery.

iii. Hannah Parkhurst. Born, 25 Aug 1724, in Plainfield, Windham Co., CT . Reference: 19323.

No further record of Hannah has been found. She probably died young.

iv. Mary Parkhurst. Born, 2 Mar 1725/6, in Plainfield, Windham Co., CT . Reference: 19324.

"Mary Parkhurst" married James Day. It was not this Mary, but rather, Mary, daughter of Timothy and

John served in the Fifth Connecticut Regiment from 11 May 1775 until 8 October 1775 as a member of Captain Beardsley's company. Subsequently he served in a New Hampshire regiment.

John and his eldest son, Simeon, both Revolutionary War soldiers, moved John's family from Orford, Grafton Co., NH to Whitestown, Oneida Co., NY, in 1792 and settled on 640 acres where the Parkhurst Cemetery is located. It is two miles northwest of Oriskany, on the north side of Route 69, just east of the Oriskany Battle Monument.

In 1814 John was taxed on 406 acres, 1 improved building, and 1 unimproved building with a valuation of \$5764. In John's will dated 12 April 1819 he gave the names of some of his children and grandchildren. The administration of his estate was granted on 14 Febuary 1820.

J. J. Parkhurst, long time resident of this city and at one time one of its most influential men, died Saturday at the home of his daughter, Mrs. R. W. Lynch, 418 Church street, aged eighty years. In earlier years he was a potent factor in the iron trade in Chicago, and his family led in Evanston social affairs.

Was in Iron Trade.

He was born in Mexico, Oswego county, New York, in 1837. He came to Chicago in 1865 to establish the firm of Parkhurst & Wilkinson, iron merchants, which continued in business until 1903. For many years he was president of the La Porte Carriage company of La Porte, Ind., and lived there much of the time in recent years.

Shortly after the great Chicago fire Mr. Parkhurst established his home in Evanston, where he resided until he removed to La Porte, some eight years ago. He lived for thirty-six years at the northeast corner of Davis and Ridge avenue, the house being torn down to make way for apartment buildings.

President of Village.

In the 70's and the early 80's he was very active in village affairs, and served for many years upon

the board of trustees. In 1882-84 he was president of the board. His interest in city affairs continued so long as he remained here. William A. Dyche, when he was mayor, said that Mr. Parkhurst had suggested to him the making of a lake front park out of street sweepings, the plan so effectively carried out by Benjamin Housel that it added millions of dollars to the value of city possessions.

At the time of his death he was, with one exception, in length of service, the oldest trustee of Northwestern University, having been elected in 1876. For many years he gave a great deal of time to university affairs and was especially valuable as a member of its land committee. The interests of the university were always close to his heart.

A Lifetime Methodist.

He was a member of the First M. E. Church and in the days of his active life in Evanston was a member of its board of stewards.

He is survived by two sons and a daughter, Jay Parkhurst of La Porte, Ind.; George Parkhurst and Mrs. R. W. Lynch of this city. His brother, Rev. M. M. Parkhurst is prominent in the Methodist church and an Evanston property owner.

Funeral services were held at 2:30 this afternoon at the home of Mrs. Lynch, 418 Church street, conducted by Dr. Timothy Prescott Frost, pastor of the First Methodist church. The pallbearers were Jay Parkhurst, George Parkhurst, Frank Parkhurst, Bennett Hamilton, Josiah Parkhurst Lynch and William A. Dyche.

Matthew Parkhurst was baptized into the Roman Catholic faith. His parents became Methodists when Matthew was ten years old. He was apprenticed to a coach maker and worked at this trade for three years. He then prepared for college at Folly Seminary, NY and graduated from Boston Theological School in 1859.

Matthew became Matthew M at some point in his life. The "M" was purely a middle initial. It did not stand for any name.

When the 1860 Census was taken, Matthew was a Methodist Clergyman in Barre, Worcester Co., MA. He owned personal
property valued at \$200.

During the Civil War, he served for one year as a First Lieutenant with Company K, Twenty-first Regiment Massachusetts Volunteer Infantry. At the request of Governor Andrew, Matthew spent the next two years recruiting and speaking for the army, meanwhile preaching at Warren, MA. Between 1864 and 1870 he had a pastorate of several Boston churches. In 1870 he took charge of Grace M. E. Church in Chicago. In October 1874 he was transferred to the Michigan Avenue Church; in 1876 to the First Church; in 1879 to the First Church at Elgin; and in 1883 to the Grant Place Church, Chicago. In 1877 he became associated with the Rev. C. G. Truesdell in the organization of the Sunday School Assembly at Lake Bluff and for the next eighteen years was very active in the promotion of that western "Chautauqua".

Matthew was probably in Scotland, when the 1880 Census was taken. He took his family back to Scotland so that his wife could give birth at her family home.

Matthew Parkhurst was baptized into the Roman Catholic faith. His parents became Methodists when Matthew was ten years old. He was apprenticed to a coach maker and worked at this trade for three years. He then prepared for college at Folly Seminary, NY and graduated from Boston Theological School in 1859.

Matthew became Matthew M at some point in his life. The "M" was purely a middle initial. It did not stand for any name.

When the 1860 Census was taken, Matthew was a Methodist Clergyman in Barre, Worcester Co., MA. He owned personal property valued at \$200.

During the Civil War, he served for one year as a First Lieutenant with Company K, Twenty-first Regiment Massachusetts Volunteer Infantry. At the request of Governor Andrew, Matthew spent the next two years recruiting and speaking for the army, meanwhile preaching at Warren, MA. Between 1864 and 1870 he had a pastorate of several Boston churches. In 1870 he took charge of Grace M. E. Church in Chicago. In October 1874 he was transferred to the Michigan Avenue Church; in 1876 to the First Church; in 1879 to the First Church at Elgin; and in 1883 to the Grant Place Church, Chicago. In 1877 he became associated with the Rev. C. G. Truesdell in the organization of the Sunday School Assembly at Lake Bluff and for the next eighteen years was very active in the promotion of that western "Chautauqua".

Matthew was probably in Scotland, when the 1880 Census was taken. He took his family back to Scotland so that his wife could give birth at her family home.

J. J. Parkhurst, long time resident of this city and at one time one of its most influential men, died Saturday at the home of his daughter, Mrs. R. W. Lynch, 418 Church street, aged eighty years. In earlier years he was a potent factor in the iron trade in Chicago, and his family led in Evanston social affairs.

Was in Iron Trade.

He was born in Mexico, Oswego county, New York, in 1837. He came to Chicago in 1865 to establish the firm of Parkhurst & Wilkinson, iron merchants, which continued in business until 1903. For many years he was president of the La Porte Carriage company of La Porte, Ind., and lived there much of the time in recent years.

Shortly after the great Chicago fire Mr. Parkhurst established his home in Evanston, where he resided until he removed to La Porte, some eight years ago. He lived for thirty-six years at the northeast corner of Davis and Ridge avenue, the house being torn down to make way for apartment buildings.

President of Village.

In the 70's and the early 80's he was very active in village affairs, and served for many years upon the board of trustees. In 1882-84 he was president of the board. His interest in city affairs continued so long as he remained here. William A. Dyche, when he was mayor, said that Mr. Parkhurst had suggested to him the making of a lake front park out of street sweepings, the plan so effectively carried out by Benjamin Housel that it added millions of dollars to the value of city possessions.

At the time of his death he was, with one exception, in length of service, the oldest trustee of Northwestern University, having been elected in 1876. For many years he gave a great deal of time to university affairs and was especially valuable as a member of its land committee. The interests of the university were always close to his heart.

A Lifetime Methodist.

He was a member of the First M. E. Church and in the days of his active life in Evanston was a member of its board of stewards.

He is survived by two sons and a daughter, Jay Parkhurst of La Porte, Ind.; George Parkhurst and Mrs. R. W. Lynch of this city. His brother, Rev. M. M. Parkhurst is prominent in the Methodist church and an Evanston property owner.

Funeral services were held at 2:30 this afternoon at the home of Mrs. Lynch, 418 Church street, conducted by Dr. Timothy Prescott Frost, pastor of the First Methodist church. The pallbearers were Jay Parkhurst, George Parkhurst, Frank Parkhurst, Bennett Hamilton, Josiah Parkhurst Lynch and William A. Dyche.

FIRST GENERATION

1. GEORGE' PARKHURST, the founder of the Parkhurst family in America was born at Ipswich, Suffolk Co., England in May, 1588, son of John and Sarah Parkhurst, and died about 1655 either in Boston or on return to London, England. He came to this country about 1635, after the death of his first wife, and brought at least some of his children with him.

The first public record in America to mention the Parkhurst name is to be found in Watertown, Mass. when, on May 10, 1642, it was ordered that a highway be laid out by George Parkhurst's house. The records show that he owned a large tract of land besides the homestead of twelve acres. In 1643 he was admitted a freeman. He sold his Watertown estate and moved to Boston in 1645.

George married (1st), in England before coming to this country, Phebe Leet, who was born in England and died there about 1635. They had at least nine children.

George married (2nd) in Watertown, Mass. November 16, 1644, Mrs. Susanna (Brown) Simpson, widow of John Simpson. Susanna was born about 1610 and died in 1690, possibly after returning to London, England.

They were living in Boston October 14, 1645 and remained as late as June 13, 1655. It is believed that they both went back to England and both died in London.

May 13, 1640 (as his second wife) Thomas Arnold, son of Thomas and Alice Arnold of Cheselbourne, Dorsetshire, England. Thomas was baptized April 18, 1599. He had married his first wife, Alice Gully, daughter of John Gully of North Over, in England and had three children by her: Thomas ARNOLD, b. May 3, 1625, d. young; Nicholas ARNOLD, bpt. January 15, 1627, d. young; Susanna ARNOLD, who married John Farnum of Boston April 7, 1654.

Thomas Arnold embarked at London, England May 15, 1635 to sail for Virginia on the *Plaine Joan*. He arrived in New England with three children and settled in Watertown, Massachusetts Bay. He was made a freeman May 13, 1640. He was fined by the court for offenses against baptism in 1651 and for neglecting public worship in 1654/5. He sold land in 1655 to his brother in law, George Parkhurst, and moved before 1661 to Providence, R.I., selling the remainder of his Watertown holdings in 1661 and 1662. He was deputy to the General Assembly of Rhode Island in 1666, 1667, 1670-72. He died at Smithfield, R.I. in September 1674. He and Phebe had five children.

Thomas was baptized July 3, 1608 at Hinderclay, Suffolk Co., England and came to America in 1635. He died at Woburn September 5, 1684. He was a graduate of a school at Bury St. Edmunds in England.

Joseph came to this country with his father and settled at Watertown, Mass. He moved to Chelmsford but the date is uncertain. However, he was living there from 1656 to 1667. His name appears on the list of proprietors of the New Field in Chelmsford. His share of twelve acres was allotted to him "1st month, 12th, 1666/7." At least the first four of their children were born in Chelmsford. (The birth of Ebenezer does not appear in the Chelmsford Vital Records.)
